Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

In compliance with Regulation 30 read with sub-para 19, Para A, Part A, Schedule III of the SEBI (LODR) Regulations, 2015, we hereby inform you that the Company has received an Order from Office of Commercial Tax Officer, Chennai vide Final Report No. ZD331125123145Z.

We wish to inform you of that on 09.07.2025, the Office of Commercial Tax Officer, Chennai had conducted an inspection under Section 67 of GST Act, 2017 on the premises of the company and seized few documents. Further summons were issued for FY 2019-20, 2021-22, and 2022-23 for non-remittance/short remittance of Reverse Charge Mechanism (RCM) on import of services.

The Company had provided detailed workings and submissions to the authorities in the month of July, 2025. After adjustment of excess payments across the relevant periods, the balance RCM amounts for FY 2019-20 and FY 2022-23 were remitted on 26.09.2025. All amounts are fully paid, and the matter has been concluded.

The Company received the physical copy of the final order on 14th November 2025 at 5:00 p.m. The GST Department in order to fulfill their procedures had issued an order of seizure dated 07th November 2025 for seizure carried in the month of July 2025.

In pursuance to SEBI circular numbered SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, and Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, additional details to be disclosed regarding the aforesaid order is annexed in **Annexure A to this intimation.**
